Absentee Voter Instructions

Please Read All Instructions Carefully Before Voting

1. Review the contents of this sample ballot. To the right of each choice is a number which is assigned to its position on the pre-scored ballot card.
2. Punch out the pre-scored ballot card only with the punching tool.
3. Use the punching tool and firmly punch out the black dot for the position number on the ballot card which corresponds with your choice. To vote for a person not on the ballot, write the office title and the name of the person in the space provided on the grey envelope.
4. Complete the affirmation on the return envelope. Place the punched ballot card in the grey envelope. Place the grey envelope containing the ballot card into the signed return envelope and seal the envelope.
5. Return by mail (please affix proper postage) or hand delivery to La Plata County Clerk and Recorder. Ballot must be received by 7:00 PM on the day of election.
