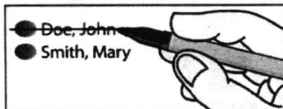

**Making selections**



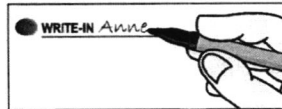
To vote for a candidate whose name appears on the ballot, FILL IN THE OVAL to the left of your choice using blue/black ink.

To vote for a qualified write-in candidate, write the person's name in the blank space provided and FILL IN THE OVAL to the left.

**WARNING:** Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both. A ballot question listed as an "amendment" proposes a change to the Colorado constitution, and a ballot question listed as a "proposition" proposes a change to the Colorado Revised Statutes. A "yes/for" vote on any ballot question is a vote in favor of changing current law or existing circumstances, and a "no/against" vote on any ballot question is a vote against changing current law or existing circumstances.</p>

**Pine River Public Library District Ballot Issue 6A**

SHALL LA PLATA COUNTY PROPERTY TAXES FOR THE SUPPORT OF THE PINE RIVER PUBLIC LIBRARY DISTRICT BE INCREASED \$337,031 ANNUALLY IN 2020 (THE FIRST FULL FISCAL YEAR) AND BY SUCH AMOUNTS AS MAY BE GENERATED ANNUALLY THEREAFTER BY AN INCREASE IN THE TOTAL MILL LEVY TO 4.0 MILLS (AN INCREASE OF 1.5 MILLS FROM THE EXISTING MILL LEVY, PROVIDED THAT THE TOTAL MILL LEVY MAY BE ADJUSTED TO OFFSET REVENUE LOSSES FROM REFUNDS, ABATEMENTS AND CHANGES TO THE PERCENTAGE OF ACTUAL VALUATION USED TO DETERMINE ASSESSED VALUATION), IN ORDER TO MAINTAIN OR IMPROVE LIBRARY SERVICES SUCH AS,

- OPERATING DAYS AND HOURS;
- BOOK AND DIGITAL COLLECTIONS;
- TECHNOLOGY UPGRADES AND BUILDING MAINTENANCE;
- YOUTH LEARNING ACTIVITIES AND SERVICES;
- ADULT EDUCATION AND SENIOR SERVICES;
